Abstract:

In this dissertation, I develop a theory of real definition. Real definitions state conditions on the identity of things and explain how they differ from other individuals or members of other kinds. My theory shows how we can know real definitions through both scientific and philosophical discovery. I then apply my theory in an argument contrary to reductionist accounts of essence and in a critical examination of Kit Fine's applications of the notion of essence to ontological dependence and the reduction of modality. Finally, I argue that the real definition of each human person accounts for their personal identity over time.
